-----AS PARTY OF THE FIRST PART: ENERGY AFFAIRS ADMINISTRATION, employee identification number 660-43-3481, represented by its Executive Director, Luis M. Bernal Jiménez, of legal age, married and resident of Guaynabo, Puerto Rico hereinafter referred to as the ADMINISTRATION.-----

-----AS PARTY OF THE SECOND PART: Puerto Rico Department of State, employee identification number 660-63-7290, a Puerto Rico governmental entity, represented by Vanessa Viera Rabelo, Executive Office, of legal age, married, and resident of Carolina, by virtue of the duties and faculties delegated under Law No. 101 of 2002, 3 PR Stats. Ann. § 53, hereinafter referred to as the Department of State, the SUBGRANTEE or the SUBRECIPIENT.

STATEMENT OF PURPOSE

-----The *Energy Efficiency and Conservation Block Grant Program* (EECBG) of the *American Recovery and Reinvestment Act of 2009, Pub. L. 111-5* (ARRA) which purpose is to assist eligible entities in creating and implementing strategies to: 1) reduce fossil fuel emissions in a manner that is environmentally sustainable and, to the maximum extent practicable, maximizes benefits for local and regional communities; 2) reduce the total energy use of the eligible entities; and 3) improve energy efficiency in the building sector, the transportation sector, and other appropriate sectors. The contracting parties would like to amend this Agreement so that additional funding is made available for the Department of State:-----

TERMS AND CONDITIONS

-----FIRST: Amend the ENERGY EFFICIENCY AND CONSERVATION BLOCK GRANT SUBGRANT AGREEMENT Contract #2011-132-031, granted on July 2010 (the "EECBG Subgrant Agreement" or the "Agreement") to release a subgrant amount of one hundred thousand dollars (\$100,000.00). Accordingly, the parties hereto agree to the following::

1. MAXIMUM OBLIGATION

The payments shall be made from the Account Number 6890-256-132-04R-2010-DE-EE0000945 (approval sheet no. 11-058). The sum of SEVEN HUNDRED THOUSAND DOLLARS (\$700,000.00) is release from the subgrant amount for disbursement. The Department of State shall provide EAA with an original bill and copies of any related invoices from the Department of State's contractor(s) or consultant(s) shall be attached thereto. The Department of State shall certify that the services were satisfactorily provided and pursuant to the terms and conditions of this contract.

-----SECOND: This amendment shall be in effect through August 31st, 2012 and may be renewed by mutual agreement of the parties.-----

-----THIRD: All Other clauses of the Agreement will remain unaltered.-----

-----FOURTH: No service or counter service object of the Agreement as amended herein can be enforced until it has been presented for record in the Office of the Comptroller of Puerto Rico in accordance with Act No. 18 of October 30, 1975, as amended -----






